

Principal's Message

Welcome to week four.

Happy Mother's Day to all of our mothers and grandmothers. I hope all of our mothers had an enjoyable weekend and were able to take some time out to enjoy time with their families as well as some well-earned rest time. On the topic of Mother's Day, I am pleased to announce that once again our primary students entered the Mother's Day art competition organised by the Lindfield Chamber of Commerce and three of our students were awarded prizes in their age category. Judging was by Yolanda Harbon, Ku-ring-gai Council's Arts & Cultural Officer. Artworks were judged on use



of space, balance & composition, use of colour and creativity. Yolanda was very impressed with the quality of the artworks from all children and took much deliberation over her selections. Congratulations to Nathan, Rayan and Ryan who will receive their prizes for their mother at this week's assembly.

It will be updated next week with a presentation of all the artworks as well as the Chamber taking over Peter Vickers Business Group Instagram's page @pvbglindfield so that anyone that can't get to the local shops can enjoy the lovely Mum artworks from all schools.

Four years ago, our school undertook the process of external validation in which we produce and present evidence sets of our work and student achievements within the Department of Education's excellence framework to Department officers external to the school. This is undertaken every four years and this year we will be participating again. The evidence sets we produce are a compilation of programming and data evidence along with photographs of students engaging in the learning outcomes associated with the data. These photos will be seen only by three Department officers and not placed on any public site including our website. I will be seeking permission from parents to include photos of their children in the submission which will not name or identify the student in any way. As this process is a reflection on the past four years the photographs used may not be current but will reflect their engagement of the evidence sited. Not all students will be involved but we are seeking permission in advance and if your child's photo is selected you will receive a copy of the page on which they appear. A permission form to use your child's photo for this purpose is included in this week's edition.

As you are no doubt aware NSW (Sydney area) has recorded two cases of community transmission of COVID 19. As a result of the many areas the infected person visited the Department has issued a small amount of precautionary measures which are in place until otherwise advised. For the most part there is little change to school operations but a reinforcement of previous advice which needs to be adhered to in regard to health of students, staff and parents. A summary of the current advice is as follows;

- Students over the age of 12 and staff must comply with the <u>Public Health (COVID-19</u>
 <u>Mandatory Face Coverings) Order 2021</u> when travelling to and from school and during school excursions by public transport or by chartered or private transport services.
- Students should not attend school if unwell, even with mild symptoms of COVID-19. Any student with COVID-19 symptoms will be sent home and should not return until they have received a negative test result and are symptom-free. In circumstances where children have other medical reasons for recurrent symptoms a letter from their GP is sufficient to negate the requirement for a negative test.

Principal's Message (continued)

- Students who do not undertake a COVID-19 test will not be permitted to return to school for a 10 day period. Additionally, they must be symptom-free for at least 3 days prior to returning to school.
- Students who have seasonal allergic rhinitis or another condition that presents similarly to
 flu-like symptoms are still required to get tested for COVID-19 and return a negative test result.
 Where their symptoms continue beyond 10 days, students should provide documentation from
 their GP confirming their symptoms are typical for their condition. If the student develops new
 or changed symptoms, they should get tested for COVID-19.
- COVID-19 testing for students with complex health or disability may be challenging. In these
 situations, schools will ask the parent or carer to have their child assessed by their medical
 practitioner. Where a medical practitioner determines that a COVID-19 test is not required,
 documentation must be provided to the school to confirm that the student does not have
 symptoms that warrant a COVID-19 test. The certificate must also indicate that the student is
 able to return to school and are symptom free.
- Visitors to schools should maintain 1.5m distance from other adults where practicable. Avoid
 congestion of groups of visitors in specific areas where possible. Please note the sign on the
 door of the school office requesting no more than four external persons in the office area at one
 time and the request to not enter if you are unwell.
- All visitors to a school site must comply with sign-in arrangements. This includes the
 requirement to sign the school sign-in sheet where they acknowledge that they will comply with
 the COVID-19 requirements for visitors, contractors and service providers each time they visit.
 Visitors must also check in using the Service NSW QR code.

All other activities and external programs may continue with a restriction for singing in indoor venues. The two square metre rule remains unchanged and COVID safety plans for indoor events within this rule remain. This should only affect students aged over 12 engaged in shopping programs and visiting venues away from school as they at this stage will be required to wear a mask which the school will provide.

We are all hoping that further restrictions will not be necessary as we are just commencing normal operations, however the safety of our students, staff and their families will always be a priority.
